In the event of any new dwelling application, a decision to hold a remote zoom meeting will be made at the discretion of the Chairman of the Council.

Prior Notification of change of use of agricultural building to 1 no. dwelling | Building At Woodhams Farm Cutlers Green Lane Thaxted Essex

Whilst this is not a planning application it is in fact a prior notification. The Parish council RESOLVED to unanimously OBJECT this is not a change of use. The changes needed to make it a habitable dwelling are so significant that it cannot meet the requirements set out in the permitted development Order. We would expect a new planning application for an additional dwelling. We would however also object to the development of a new house on the basis that it would be contrary to both policy S7 in the Local Plan and policy TX LSC4 of the Thaxted Neighbourhood Plan.'

19/20.759 5 YEAR LAND SUPPLY AND HOUSING TRAJECTORY

To **NOTE** the 5 year land supply

Uttlesford have recently reassessed their land supply, there is now a 3.11 year land supply so this would have had a significant effect on our neighbourhood plan, there is a two year window where this is significant and there is around a 3 week opportunity for us to fall heavily on our NP.

19/20.760 LOCAL PLAN CONSULTATION

Cllr Frostick and Howells both attended a forum last night in connection to the local plan. The Call for sites is being considered around the 1st April where more information will be decimated from this.

19/20.761 CREATION OF A NEW WORKING GROUP

The Chairman reports that Ian Stewart has stepped down from the council and we wish him well in his endevours, Ian still remains a member of the CLT in a personal capacity. As such, this resignation has resulted in a vacancy on the Parish Council and left an opening on a committee. The Clerk has advertised the vacancy via the usual channels and the closing date for registered interests is in fact today, from this point on a co-option notice will be displayed. After some discussion it is decided that the following committee amendments will take place.

- a) **RESOLVED** To create a **COMMITTEE** of the **COUNCIL** (not a working group) with delegated powers, to deal with all related matters in connection to the local plan consultation process. This committee would include no more than two external council members.
- b) Cllr Frostick proposed to elect Richard Haynes and chairman, seconded by Cllr Williams **RESOLVED** to **APPOINT** Richard Haynes as Chairman

RESOLVED to **APPOINT** Cllr Andy Frater as Vice Chairman

All councillors are members of the committee and may attend meeting at their will. Core Working committee members are: Cllr A Frater, Cllr R Barrington, Cllr Spencer

This action **DISSOLVES** the committee which was created and resolved in October 2020 known as the Thaxted Development Committee. The new committee name will be the **'Thaxted Local Plan Committee'**

We are in a position that the Cricket club have the benefit of occupation and have granted permission for the individual, it is not either parties desire to cause conflict, if however the cricket club are willing to relinquish this portion of land to be 'no longer within their control' then we may create a licence of the land to the other party.

It is **RESOLVED** that The Clerk with assistance from Cllr Knight will create such documents and make contact accordingly with all parties concerned.
